Sub: Diversion of 2.08 ha of Reserved Forest land for construction of Van Bhavan of Administrative Office in favour of Conservator of Forests, at Village-Bhomburda, in Pune District, Maharashtra - Regarding

Sir,

I am directed to invite reference to the Nodal Officer Maharashtra letter No. Desk-17/NC/II/2488/10-11 dated 11/11/2010 and even dated 09/12/2010 on the above mentioned subject seeking prior approval of the Central Government under section 2 of the Forest (Conservation) Act, 1980.

After careful consideration of the proposal of the State Government, the undersigned on behalf of the Central Government, hereby agrees in principle for diversion of 2.08 ha of Reserved Forest land for construction of Van Bhavan of Administrative Office in favour of Conservator of Forests, at Village- Bhomburda, in Pune District, subject to the following terms and conditions:-

- 1.. The legal status of the forest land shall remain unchanged.
2. Compensatory Afforestation shall be taken up over 4.16 ha suitable degraded forest land, at the cost of the User Agency. A proposal for the same will be sent to this office along with map of the area and land suitability certificate.
- 3.. The cost of compensatory afforestation shall be deposited in advance at prevailing wage rates with the Forest Department.
- 4..(a) The State Government shall charge Net Present Value (NPV) for the 2.08 ha of forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008 and 09/05/2008 in IA-566 in W.P. (Civil) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No.5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No.5-2/2006-FC dated 03/10/2006 in this regard.

- (b) Additional amount of the NPV of diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. It shall furnish an undertaking to this effect.
- 5.. All the funds received from the User Agency under the project shall be transferred to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in A/c No.CA 1575 of Corporation Bank, Block-11, CGO Complex, Phase-I, Lodi Road, New Delhi- 110003.
- 6.. The prior concurrence needs to be obtained in case the facilities created are to be used by any organization other than the Forest Department.
- 7.. The Project Authority will defray the cost of removal of 24 trees in the area, which is falling under diversion.
- 8.. The Project Authority will submit detailed plans, designs and estimates for the proposed building at the time of Stage-I compliance.
- 9.. The diversion of forest land of the proposed project will be confined to 2.08 ha only.
10. In addition to the proposal, any additional construction of building in future, the User Agency will approach for approval from this office.
- 10.. Forest land shall not be utilized for any purpose other than specified in the project proposal.

After receipt of compliance report on fulfillment of conditions Nos 2, 3, 4, 5 & 7 from the State Government, formal approval will be issued in this regard under section - 2 of the Forest (Conservation) Act, 1980.

The order for diversion of forest land to User Agency shall not be issued by the State Government till formal approval order is issued by this office.
