Sub: Diversion of 2.08 ha reserved Forest land for construction of Van Bhawan of Administrative Office in favour of Conservator of Forests, at Village- Bhomburda in Pune District of Maharashtra - Regarding.

Sir,

I am directed to invite reference to the Chief Conservator of Forests and Nodal Officer, Maharashtra letter No Desk-17/II/2488/10-11 dated 11/11/2010 and even dated 09/12/2010 on the subject cited, seeking prior approval of the Central Government under section - 2 of the Forest (Conservation) Act, 1980.

The Central Government vide this office letter (1) cited had agreed in principle for diversion of 2.08 ha reserved forest land for the purpose mentioned, subject to the fulfilment of condition Nos. 2, 3, 4, 5 & 7 stipulated therein.

The State Government vide letter (2) referred above have reported compliance on fulfilment of the stipulated conditions.

Therefore, the undersigned hereby conveys formal approval of the Central Government under section - 2 of the Forest (Conservation) Act, 1980 for diversion of 2.08 ha reserved Forest land for construction of Van Bhawan of Administrative Office in favour of Conservator of Forests, at Village- Bhomburda in Pune District, subject to the following terms and conditions:-

The legal status of the forest land shall remain unchanged.

- Compensatory afforestation shall be taken up over 4.16 ha of Degraded Forest land, in Gut No.1986 (old Survey No. 182 Pt), Village-Loni Kalbhar, Tal. Haveli, District Pune, at the cost of User Agency, within two years from the date of sanction of this approval.
- The prior concurrence needs to be obtained in case the facilities created are to be 3... used by any organization other than the Forest Department.
- The diversion of forest land of the proposed project will be confined to 2.08 ha 4..
- In additijon to the proposal, any additional construction of building in future, the 5.. User Agency will approach for approval from this office.
- The forest land shall not be used for any purpose other than that is specified in 6.. the project proposal.
